## WHAT INFORMATION DO WE COLLECT, HOW DO WE COLLECT IT AND HOW DO WE HANDLE IT?

When you visit our website we may gather usage information to help us improve our website experience for our visitors. This information may include your IP address, geographical location, browser type and version, operating system, how you found our website, the length of time you spent on our site, which pages you visited and website navigation paths. We use cookies to help us track these activities. We will ask you to consent to the use of cookies when you first visit our website. Usage information is processed for the purposes of analysing the use of the website. The legal basis for this processing is our legitimate interests, namely monitoring and improving our website.

We collect personal information when you submit a form, send an enquiry, complete a job application or otherwise provide us with personal information, such as your name, address, telephone number and email address. We only use this information for the purpose it has been given such as processing your job application, for marketing purposes and if you have given your consent for us to do so. Further, we will use your data to respond to your enquiries.



## WHO HAS ACCESS TO YOUR INFORMATION AND WHERE IS IT STORED?

The information you submit will be passed to the relevant department at Biogenie UK, based on the nature of your enquiry, for example, a job application will be passed to the Human Resources department. Your personal data may be stored outside of the European Economic Area (EEA), for example, because some of our servers are based in the USA. Any personal information that is stored in the USA will be done using the adequate safeguards permitted by regulators for transfers of personal data outside of the EEA. We require third parties to respect the security of your data and to treat it in accordance with the law.

We require those companies to keep your personal data confidential and secure and to protect it in accordance with the law and our policies. They are only permitted to process your data for the lawful purpose for which it has been shared and in accordance with our instructions.

## WITHDRAWING CONSENT OR CHANGING YOUR INFORMATION
